### Test report University of Düsseldorf

---

Bardahl hand cleanser has been extensively tested by the skin clinic of the medical faculty of the University of Düsseldorf, West Germany. This institute is a leader in the research into cleaning agents, their effect, and their influence in practice. During the test, the skin of 50 subjects was continuously exposed to the product 24 hours a day for three days. In addition, no skin change was observed in any of the subjects.
